

# SCHOOL NUTRITION MEALS SERVED AND REIMBURSEMENTS DURING THE COVID-19 PANDEMIC



## ABSTRACT

An analysis of USDA FNS data comparing number of meals served and reimbursements between School Year (SY) 2019-20 and SY 2020-21.

### **ABOUT THIS REPORT**

This report compares meals served and reimbursements in the National School Lunch Program (NSLP), School Breakfast Program (SBP), and Summer Food Service Program (SFSP) in the first school year during which the pandemic began (SY 2019-20) to the first full school year of the pandemic (SY 2020-21). The reasoning behind the focus on these specific time periods is to compare full school years to determine some of the effects of the COVID-19 pandemic on school nutrition program participation and finances.

The data used is publicly available USDA Food and Nutrition Service (FNS) data from the <u>June 2021</u> and <u>September 2020</u> Keydata Reports (see footer for references). The USDA summary pages of the Keydata reports note that, "This report data is based in part on preliminary data submitted by various reporting agencies. User should anticipate changes in future reports as reporting agencies finalize data."



# Meals Served

There were 676,899,359 fewer meals (breakfasts and lunches) served in SY 2020-21 as compared to SY 2019-20. This amounts to a 10.94% loss in meals served.





In SY 2019-20, SFSP meals accounted for 12.06% percent of total meals served. In SY 2020-21, SFSP meals accounted for 54.07% percent of total meals served, an increase of 42.01% of all meals served.

Figure 3. Meal Type as Share of Total Meals: SY 2019-20 vs. SY 2020-21





The number of total lunches served in SY 2020-21 was down 17.76%, or 692,975,102 lunches, compared to SY 2019-20.


Figure 4. Total Lunches Served by Month: SY 2019-20 vs. SY 2020-21



## <u>Reimbursement</u>

Total reimbursements for NSLP lunches, SBP breakfasts, and SFSP meals in SY 2020-21 were **up 9.25%**, or \$1,450,522,640, compared to SY 2019-20.\*
